**Milan, 26 February 2025** - Pursuant to and for the purposes of Article 102, paragraph 3, of the Legislative Decree No. 58 of 24 February 1998, as amended (the "**CFA**"), as well as of Article 37-*ter*, paragraph 3 of the Issuers' Regulation, BPER Banca S.p.A. (the "**Offeror**" or "**BPER**") hereby announces that today has filed with CONSOB the offer document (the "**Offer**") relating to the voluntary public exchange offer, pursuant to and for the purposes of Articles 102 and 106, paragraph 4, of the CFA (the "**Offer**"), on all the ordinary shares of Banca Popolare di Sondrio S.p.A. (the "**Issuer**" or "**BP Sondrio**") admitted to trading on Euronext Milan, organized and managed by Borsa Italiana S.p.A. ("**Borsa Italiana**").

The Offer relates to maximum no. 453,385,777 ordinary shares of the Issuer (*i.e.* all shares issued by BP Sondrio as of today's date) (the "**Shares**" or "**BP Sondrio Shares**"), including no. 3,630,116 treasury shares held from time to time, directly and indirectly, by the Issuer (the "**Treasury Shares**").

It is hereby reminded that BPER will recognise - for each Share of the Issuer tendered to the Offer - a consideration per share, equal to no. 1.450 newly issued ordinary shares of the Offeror with no par value, regular dividend entitlement and the same characteristics as the BPER ordinary shares already outstanding on the issue date, which will be listed on Euronext Milan (the "**Consideration**"). Therefore, for each no. 20 Shares of the Issuer tendered to the Offer, no. 29 newly issued ordinary shares of the Offeror will be recognised in exchange.

On the basis of the official price of the Offeror's shares recorded at the end of 5 February 2025 (*i.e.*, the last trading day preceding the date of the announcement made by the Offeror

The Offer is launched in Italy, as the BP Sondrio Shares are listed exclusively on the Euronext Milan, and is addressed, on a non-discriminatory basis and on equal terms, to all the shareholders holding BP Sondrio Shares. The Offer has not and will not be made to the public in the United States and has not been and will not be made in Canada, Japan, Australia and any other jurisdiction where making the Offer or participating in the tender would not be in compliance with financial or other laws and regulations of any such jurisdiction, or would require prior registration, approval or filing with any regulatory authority.
